212. Attendance and Apologies

216. Somerset Councillor Report

217. Public Question Time

A member of the public commented on the hedge works to be discussed, advising that they thought the track on the outer boundary was owned by the parish council and may need to be cut as well. The council advised it would look into the matter of the hedge along the track.

Update on application 21/00503/OUT: Land Os 3346 Thorney Road Kingsbury Episcopi Outline planning application all matters reserved except for access; Erection of up to 25 dwellings, demolition of single storey extension to no. 18 and rearrangement of estate road to facilitate access between 18 and 19 The Avenue.

220. Cemetery and Churchyard Maintenance:

Quotation was received for maintenance of the hedge to the inner boundary to the north of the cemetery. Councillors were happy with the quotation but deferred the decision to proceed while investigation into ownership of the track to the outer boundary was investigated. To be revisited in October.

It was noted that the hedge belonging to the property bordering the southern churchyard boundary has been cut, and the council are appreciative of the prompt action of the property owner in addressing this.

Comment was received regarding additional requirements for maintenance in the Churchyard. It was noted that the wildlife group were still waiting for feedback from the diocese in terms of managing the churchyard as part of the Wilder Churches initiative and sensory garden project. Until this progresses a proper maintenance regime will not be established.

Updates

- a. Local Community Networks A permanent link officer has now been appointed to support the parishes in the network. The next meeting is on the 18th September. - b. Wildlife Group No updates over the summer period.
- c. Sensory Garden As reported previously, plans have been submitted to the PCC but feedback has not been received yet and as a result the project has not progressed. The Clerk and Cllr Loxston will formally write to the PCC so it can be moved forward.
- d. Cemetery & Churchyard Topple tests were carried out and some memorials were identified for monitoring. The iron railing between the churchyard and cemetery are deteriorating and need addressing, which Cllr Loxston offered to assist with.
- e. SID Enquiry was made as to whether the SID could be located along Bladon Hill for vehicles approaching the school. The location will be investigated.
- f. Lock-up Land Registry are indicating the councils application for ownership is valid and is progressing. The parish council are extremely appreciate of the efforts of Mr Jeffrey undertaking this task on behalf of the council and community.
- g. Defibrillator Dates will be published once training can be organised.
- h. Highways Councillors discussed the Kier enhanced service provision which is now available to parishes, but did not feel it would offer value for money to the parish. It was noted that road closures for re-surfacing are about to commence, but that an issue being investigated by Wessex Water by Lower Burrow Corner and Little Lane have not been resolved which will no doubt affect the quality and longevity of the surfacing works.
 Residents are encouraged to continue reporting any issues on the roads, such as potholes or
 - damaged structures, directly to Somerset Council so they can be accurately recorded and dealt with as promptly as possible.
